

Democratic Hunter Empire

ENACTED LAW

Military Law - ID:0002

To establish formal military powers and to preserve the peace.

SECTION (0) – DEFINITIONS

- (a) DHE is an acronym of the Democratic Hunter Empire, and DHE Hunters are official Hunter members of the Democratic Hunter Empire.
- (b) Military is any organized armed forces, and as defined below.
- (c) Vassals means anyone who is a Vassal under the Law of Vassals.
- (d) Military Law means this law, and other affected laws.
- (e) DHE Military Personnel are DHE Hunters who formally serve within the DHE armed forces, and as defined below.
- (f) DHE Military Assets are objects, funds, territories, intelligence, within or allocated for the DHE military, and as defined below.
- (g) International agreements are foreign agreements involving and agreed by the DHE, including peace treaties and armistices.
- (h) Commander-in-Chief is the DHE Emperor, and as defined below.

SECTION (1) – Military Organization

(a) All DHE Hunters are part of DHE Militia forces, except:

(a.i) Hunters who are nationless;

(a.ii) DHE Hunters who are disabled, weakened, formally excepted, or unable to serve;

(a.iii) Vassals who opt-out of DHE Militia forces.

Foreign Hunter allies and aids may join the DHE Militia while remaining sovereign from the DHE.

(b) DHE Military Personnel shall serve within the DHE Hunter Legion to perform peacekeeping duties and other mandates by the Commander-in-Chief.

(c) Elite DHE Military Personnel shall serve within the DHE Elite Cohort, defined as:

(c.i) recognized by Head of State and their designated authorities;

(c.ii) strategically and militarily superior to the DHE Hunter Legion.

(d) No DHE Military Personnel shall be segregated, unless the DHE Military Personnel:

(d.i) conducted bad faith as determined by Judiciary;

(d.ii) committed unlawful acts;

(d.iii) harmed international agreements;

(d.iv) acted against the Commander-in-Chief.

DHE Militia shall not be segregated under nationality, including being nationless or under another Hunter nation, that the DHE Militia:

(d.v) is not reputed for operating for Vampires;

(d.vi) is not reputed for operating for enemy organizations of the DHE.

(e) DHE Emperor is the Commander-in-Chief of DHE armed forces, as designated by the Supreme Law, who:

(e.i) is subjected to Supreme Law and Judiciary;

(e.ii) is the supreme leader of DHE armed forces after the DHE Constitution;

(e.iii) must immediately cede supreme leadership of DHE armed forces to renewed Emperor after Head of State elections.

(f) All DHE military forces, persons, leaders, and entities swear loyalty to the DHE Constitution and to protect and serve the DHE Constitution.

SECTION (2) – Collective Security

- (a) DHE Hunters may enlist as DHE Hunter Personnel, as designated by the DHE government.
- (b) Vassals may opt-out of DHE Militia, as designated by the DHE government through official DHE communication channels, and by other future methods.
- (c) DHE Military Assets shall be allocated weaponry, defenses, territories, intelligence, and other tangible allocations for military purposes, that:
 - (c.i) may only be used for military purposes as designated by the Commander-in-Chief;
 - (c.ii) gained by: contributions from DHE Hunters and allies, through DHE government emergency retrieval orders, and other receptive means by the DHE government;
 - (c.iii) used during active preparation and/or war time, by DHE Military Personnel.

SECTION (3) – Military Branches

- (a) DHE Militia branch where all DHE Hunters are reserved under military conscription.
- (b) DHE Hunter Legion branch is the military volunteer branch for DHE Hunter Personnel, defined under SECTION-(1)(b).
- (c) DHE Elite Cohort as defined under SECTION-(1)(c) who receives personnel promoted from the DHE Hunter Legion into the DHE Elite Cohort.
- (d) DHE Military Justice and Internal Affairs (“DHE MJIA”) branch shall be enacted when large military operations are undertaken who serves martial law and justice, while dormant the DHE Judiciary shall fulfill obligations on behalf of the DHE MJIA.

SECTION (4) – Foreign Policy

- (a) No DHE Hunter Personnel shall autonomously commit acts against international agreements, unless:
 - (a.i) in self-defense, in respect to SECTION-(4)(b);
 - (a.ii) in defense for another, in respect to SECTION-(4)(b);
 - (a.iii) government approve retaliation or preemptive defensive measures.
- (b) DHE Hunters and DHE Militia shall appropriately react in face of another entity by the Official DHE blacklist or Kill on Sight (“KoS”) list therefore overruling SECTION-(4)(a.ii), who lost defensive rights under the DHE blacklist, and eliminate entities on KoS. DHE Hunters and DHE Militia shall not engage entities by the official DHE whitelist unless excepted by SECTION-(4)(a).

SECTION (5) – Counterintelligence

- (a) Ministry of Counterintelligence may investigate the DHE Military during peace, active, and war time.
- (b) Ministry of Counterintelligence shall collaborate with DHE MJIA branch on DHE MJIA request or under DHE government approval.

SECTION (6) – Interpretation of Eligibility

- (a) All Vampires Hunters have equal opportunity to join the DHE Militia under compliance with SECTION-(1)(d), if the Vampire Hunter:
 - (a.i) is not on the Official DHE Blacklist or Official DHE Kill on Sight list;
 - (a.ii) does not aid an enemy organization;
 - (a.iii) willing to perform military operations.
